WHO MAY APPLY:

Open to all members of the Virginia Air National Guard, or who are eligible to become members of the Virginia Air National Guard (NATIONWIDE). Must have the following grades A1C/E-3 NTE MSgt/E-7 TSgt/ E-6 and MSgt/E-7 grades contingent on position availability. (4 positions available)

REQUIRED QUALIFICATIONS: Must meet all selection criteria IAW ANGI 36-101 Chapter 5, AFI 36-2905, AFI 48-123.

BRIEF DESCRIPTION OF DUTIES AND RESPONSIBILITIES:

(1) Serves as a Communications and Information (C&I) systems technical consultant and provides assistance to supported C&I Systems Officers (CSO's) with communications and information system configuration control. Develops short/long-range planning, programming, implementation and funding strategies for deploying C4I systems and infrastructures. Ensures current and proposed infrastructures meet ANG Communications Information System Architecture. Joint Technical Architecture - Air Force (JTA-AF) and applicable Major Command (MAJCOM) communications standards.

(2) Develops, updates, and maintains the base C4I Systems Blueprint, which includes the communications and information system baseline infrastructure. Prepares and proposes solutions for implementing infrastructure upgrades at base level. Develops Blueprint Phased Implementation Directives (BPID) which provide an overview, broad gauge and technical solution, logically phased implementation, and comparison cost summary to include engineering, allied support and installation via contract personnel or ANG resources. Develops comprehensive Statements of Work for use by base planning and contractor personnel in awarding C4I engineering and installation services. Identifies funding requirements, advocates funding approval, and offers assistance in obtaining funds.

(3) Assists the CSO and communications and information planner by helping define user mission needs. Identifies acquisition-funding requirements for inclusion in budget submissions during the Program Objective Memorandum (POM) process. Advises base-level planners on acquisition, implementation, and time schedule requirements. Develops acquisitions and fee-for-service funding strategies for new C4I requirements.

(4) Analyzes and interprets USAF and ANG long-range communications requirements. Identifies current and long-range C4I development plans and develops target C4I architectures, based upon forecast mission requirements. Consults with and advises base planners during the development and preparation of new C4I architectures and ensures conformance with applicable policies, standards, and guidelines. Validates C4I requirements documents for system integration, technical solution and costing.

(5) Develops and presents economic and implementation feasibility proposals and/or recommendations consisting of cost comparisons of differing technologies to base planners and NGB functional area experts. Develops technical solutions and BPIDS to support emerging missions. Reviews C4I projects to ensure proper alignment with base master plans, current DoD, AF, and ANG architectures.

(6) Provides program management liaison with the base program manager to resolve problems related to

blueprints, Program Management Directives, Communications Systems Directives, Communications Systems Requirements Documents and other implementation issues. Serves as liaison between the project engineer and the customer when problems or delays occur. Interprets policies and practices to ensure effective project implementation.

(7) Performs other duties as assigned.
