## Francis Stonnell Dies



CMS Francis Stonnell died suddenly on June 27th. He had worked that day, and had just recently passed a flying physical examination. He is survived by his wife, Phyllis G. Stonnell of 8303 Colebrook Road, Richmond, Va. He was forty-eight.

Born in Cumberland County, Va., he graduated from Hamilton High School at Cartersville, Va., and enlisted in the service in August 1939. During WWII he served in the Southwest Pacific Theater from February 1942 to October

1944. During his long military career he had received the Air Force Reserve Medal, American Defense Service Medal, Asiatic-Pacific Campaign Medal, Distinguished Unit Citation, National Defense Service Medal, World War II Victory Medal, Good Conduct Medal, AF Longevity Service Award with oak leaf cluster, Air Reserve Forces Meritorious Service Ribbon, and Small Arms Expert Marksmanship Ribbon.

CMS Stonnell has been with the VaANG as a technician since October 1947, participating in both the Korean and Berlin Crisis call ups. He has been the Aircraft Maintenance Superintendent for the VaANG since 1961.

Services were held on Monday, June 30th, with a full military funeral provided by the VaANG.

It often spells trouble for people to write their own wills. A "do-it-yourself will" often lacks such essentials as a date or a signature. It may be invalid. It often ignores important tax-saving provisions which can preserve an estate.

Other common errors often found in homemade wills are failure to dispense with the requirement for an executor's bond, especially where a husband or wife is named as executor. This may be costly.

Or failure to give the executor power to sell estate property to pay debts, taxes, court expenses and cash bequests. Without this power, the executor may have to make badly timed sales that bring losses or disrupt a business.

The amateur may also fail to describe his property and heirs properly, or name other heirs if the first should die before the writer, or forget to make cash bequests properly so they will still be carried out, even if his estate should shrink in value or be subject to heavy expenses.

The will must state clearly any inheritance provisions that limit an heir's right to contest the will. Also, it must make clear whether the beneficiary or the executor is to pay death taxes.

The legal assistance officer is the man to contact for advice on wills. He can prepare one for any particular situation.

### "SORRY BOUT THAT"

Eielson Via Mountain Home and Elemendorf

The planned exercise, Punch Card VI was cancelled Friday 20 June 1969 by the Alaskan Army Force due to extreme fire hazard conditions. The notice of cancellation caught the support personnel who had departed Byrd Field the day before enroute necessitating a diversion for the troop movement. Two of the C-130s carrying personnel and equipment were diverted into Elemendorf AFB, Anchorage, Alaska where they remained for two days before returning to Byrd Field on Monday, 23 June 1969. The other C-130 was diverted over Canada into Mountain Home AFB, Idaho, where the personnel remained at the renowned resort town of Mountain Home just outside the base until Sunday, when they departed for home arriving Byrd Field that same evening.

The pilots and enroute support personnel had not departed Byrd Field when the exercise was cancelled. The pilots then departed on cross country trips in many directions. All the personnel scheduled to take part in exercise were extended an opportunity to remain on active duty at Byrd Field for the duration of the planned exercise.

All in all, most of the personnel tasked for the exercise showed disappointment that the exercise had been cancelled.

TSgt. Carper W. Hutchison has been named the outstanding N.C.O. of the month of June for the 192d.
