# MINI-0 RI 11&12 APRIL 1970

On 11 April 1970 the 192d Tactical Fighter Group will be tested on a Mini ORI by personnel from the 108th Tactical Fighter

The Unit will be tested on its capability to process and deploy personnel and materiel in accordance with the Unit ORI time schedule of events. The capabi-lity of home base units to de-ployment and the adequacy and effectiveness of mobility planaing actions.

Some of the important evaluation factors are as follows:

Personnel processing will continue until all mobility positions of the single augmented Tactical Fighter Squadron have been processed, or until halted by the Inspection Team Chief.

INSPECTION IN-RANKS

In connection with the MINI ORI the Saturday, 11 April, UTA will begin with an Inspection In-Ranks on the Aircraft Ramp. The uniform for this inspection will be the Service Blue with Visor Cap.

After the inspection and until further notice the uniform is optional. You may wear either 1505's, Blues or fatigues, as appropriate or as directed.

#### FIELD TRAINING IN SAVANNAH

Annual Field Training for the 192d Tactical Fighter Group and attached units is scheduled for 8-22 August 1970 at Travis Field, Savannah, Georgia.

There is a possibility that some sections, or portions of sections, may train at different locations. A few examples: Comp-troller & JAG - Myrtle Beach AFB, a few Security Police - Shaw AFB, Civil Engineering Flight - unknown, etc.

Home Base Detachment will be held to a minimum this year since we anticipate very few personnel will be attending summer school

during this period.

Permission to attend Annual Field Training at another time in order to attend summer school will be considered only when it can be proved that the required subjects are not available during the first semester of summer school.

Do you want to drive your car to camp. If you possess a five (5) Level AFSC you may request permission to travel by TPC from your Squadron Commander not later than 17 May 1970. If you travel by TPC, you will be strictly on your own (your own time and your own expense) and the Government cannot assume any responsibility in the event of an accident or other trouble.

The June UTA has been rescheduled from the 13 & 14 to 20 & 21 to prevent conflicts with the Puerto Rican Deployment.

DEPLOYMENT TO PUERTO RICO

The 192d Tactical Fighter Group will assume the Air Defense responsibilities of the Puerto Rico Air National Guard while they attend their Annual Field Training, 30 May thru 15 June 1970.

At least twelve pilots and approximately fifty support personnel will deploy to San Juan on 30 May 1970. Support types required for this mission are aircraft maintenance, vehicle maintenance, drivers, fire fighters, operations clerks, supply specialist and POL. If you qualify and can get away for a couple of extra weeks, see your Squadron First Sgt this UTA.

During this period, a minimum of 12 intercept sorties will be scheduled each day to assist the local AC&W Unit with their training.

The majority of personnel will remain for the entire period, however, some may be rotated to give others the opportunity to see Puerto Rico.

#### ALL GIRL HONOR GUARD TO PERFORM

On Saturday April 11, 1970, at 1220 hours, the Huguenot High School Honor Guard will perform in front of the hangar. This is an all girl military precision rifle drill team consisting of 18 members and commanded by Diane Alley, a senior at Huguenot High School. The Honor Guard currently holds a first place National Championship title in precision movements, won April 19, 1969 at Fort Myer, Virginia, where the drill team competed against the top girls and boys teams in the Eastern United States.

Plan to be on hand, and offer the team a military audience, as this will be in preparation for the up-coming national competition to be held April 18, 1970 at Fort Myer, Virginia. This will be a well spent 10 minutes.

CAPSULE LAW (An AFNS Feature)

The Internal Revenue Service has devised a form (Form 1040X) which may be used to correct an individual income tax return filed on Form 1040A or Form 1040. The Form 1040X must be filed within three years from the date the original return was filed, or within two years from the time the tax was paid, whichever is later. This limitation is extended to seven years for deductible bad debts or worthless securities.

This recent form precludes the need to file a complete new form for the year that the erroneous return was filed and identifying it to be an "amended" or "corrected" return, as was previously required.

The use of Form 1040X is not mandatory, although IRS prefers that it be used to correct individual returns. Additionally, it will be to your advantage to use the new form, particularly if the error you are correcting will result in a return of taxes to you, since its bright yellow color is designed to expedite processing.

Form 1040X is simple to use. Most questions regarding the taxability of certain types of income, allowability of certain expenses as deductions from income, etc., are answered in the instructions for Form 1040A or Form 1040 and related schedules and forms.

Where the Form 1040 and instructions require a schedule or form to be attached, the Form 1040X will also require the attachment of that form. For example, if rental income is decreased, Part II of Schedule B, Form 1040, should be completed and attached to the Form 1040X.

### Truth in Lending Law and

WASHINGTON (AFPS) — The Truth in Lending Law makes it casier to know two of the most important things about the cost of credit:

of credit:

—The finance charge.

—The annual percentage rate.

Both the finance charges and the annual percentage rate must be displayed prominently on the forms and statements used by a creditor.

Many of us know what interest is—six per cent per year for example, Let's suppose you borrow \$100 for one year and pay six per cent — or \$6 — for that money. If you have use of the entire amount for one year you are paying an annual percentage rate of six per cent. But if you repay the \$106 in 12 equal monthly instalments, you do not have use of the entire amount for the full year. In fact, over the entire year you have the use on the average of only about half the full \$100. So the \$6 charge for credit in this case becomet an annual percentage rate of 11 per cent.

Some creditors levy a service charge or a carrying charge or some other charge instead of interest, or perhaps they may add these charges to the interest. Under the Truth in Lending Law they must now total all such charges, including the interest, and call the sum the finance charge. And then they must list the annual percentage rate of the total charge for credit.

The Truth in Lending Law does not fix interest rates or other credit charges. Your state may have a law setting a limit on interest rates, which would still apply.

Chances are, then, that if the monthly statements and other materials you receive from companies giving you credit look different now, it doesn't mean they've changed their rates, only their way of showing them to comply with the Truth in Lending Law. Your department store bills, for example, should now list both a monthly rate (for example, one per cent, 11/2 per cent, or some other number) and the annual percentage rate. This may be 12 per cent, 18 per cent or some other percentage, but it will usually be 12 times the monthly rate.

The law also gives a new look to the advertising of credit terms. It says that if a business is going to mention one feature of credit in its advertising, such as the amount of down payment, it must mention all other important terms, such as the number, amount, a

formed decisions.

One other important provision of the law is designed for your protection in case your home is used as collateral in a credit transaction. This frequently occurs when you are having a major repair or remodeling job done on your home. Now, when you enter into a credit transaction in which your home is used as collateral, the law gives you three business days to think about it and to cancel the transaction during that period if you wish. The creditor must give you written notice of your right to cancel, and if you decide to cancel the transacton, you have to notify him in writing.

Under this right of cancellation, the contractor cannot start work until the three days are up. You may give up your right to cancel and get the work started without the three-day wait, if you notify the contractor in writing that you face a real financial emergency and need the credit immediately to finance repairs necessary to avoid danger to you, your family, or your property.
