

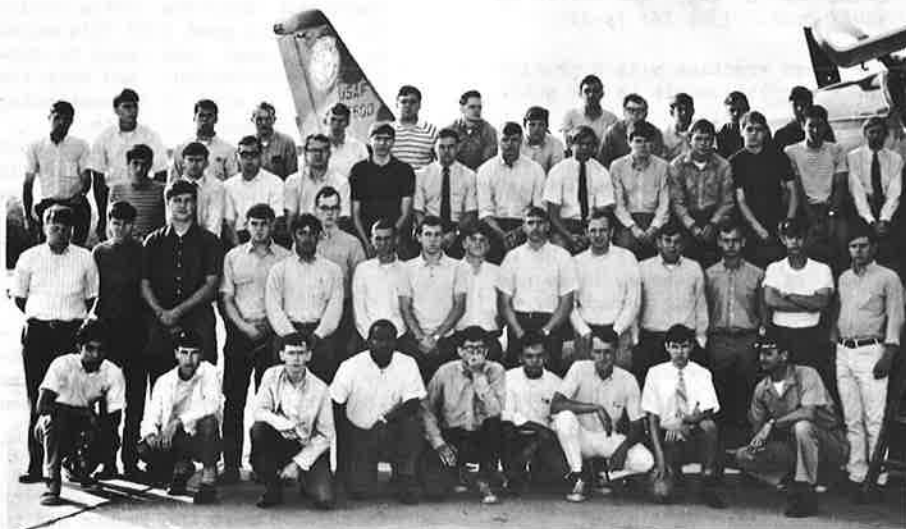

## Va ANG Enlists Fifty New Airmen!!!

Fifty non-prior servicemen were enlisted in the Virginia Air National Guard in three days.

A message was received early on 28 April authorizing the enlistment of 50 new men providing they could be on board by 30 April 70.

An assembly line was established immediately. Phone contacts were started and by noon, 28 April 1970, three (3) men were enlisted, photographed, fingerprinted etc. Six (6) more were on board that afternoon.

By 1930 hours, 30 April 1970, all fifty had been tested and enlisted.

Normally, to enlist a quota of this size, a time span of 30 to 60 days is available. However, as in the past, our personnel proved again that "when the chips are down - they can produce."

Congratulations are in order for all who assisted in this task - Personnel, Admin, Training, Air Advisor, Medics, Security Police, etc.

The fifty new airmen will attend basic during the first half of FY71. The school starting dates range from July 1970 to the middle of December 1970. Starting 1 July, these new men will not be allowed to attend UTA's until they have completed their active duty period.

### MILITARY PAY RAISE

On 15 April 1970 President Nixon ordered an eight point one percent (8.1%) pay raise to all members of the military.

Members of the Reserve Forces on active duty 15 April 1970 will receive a retroactive payment for all active and inactive duty performed during the period 1 January through 15 April 1970.

Members in a drill pay status on 15 April 1970 will receive a retroactive payment for all inactive duty performed during period 1 January and 15 April 1970.

Payments made after 15 April 1970 will be made at the increased rate.

Checks for retroactive pay will be delivered to all members on or prior to 30 June 1970. Request all inquiries pertaining to retroactive pay be held until payment has been made.

CAPSULE LAW  
(An AFNS Feature)

Taking a shortcut through a stranger's unfenced backyard, a man was attacked and bitten by the homeowner's dog. The man sued for his injuries; the defendant admitted that his dog was vicious, but argued that this was the very reason he kept the dog chained in his backyard--to protect his property.

The court held for the plaintiff. The judge said that the safety of human life must not be unnecessarily endangered in the protection of property.

Generally speaking, the law considers the keeping of a vicious dog similar to the keeping of a dangerous weapon. The dog, like the weapon, must be handled with extreme care. Against an innocent trespasser, the property owner has no more right to use a vicious dog than to use a gun.

Some courts have adopted a doctrine of almost absolute liability on the owners of vicious dogs. Questions about the law governing vicious dogs should be referred to base legal assistance officers.

CAPSULE LAW  
(An AFNS Feature)

A lightweight, solid-state, battery-operated metal detector for quick search of people and objects for concealed metal, called a Frisker, is being produced commercially. Similar devices have been used by the military to check suspects for weapons. The new model has been designed and adapted for much broader usage.

The Frisker may be employed for security use by police and Government agencies, and used in related problems by public carriers and institutions, food packagers, industry, department stores, etc. The Frisker can detect metal and partially metallic objects through wood, cement, earth, vegetation, clothing, body organs and other materials.

It will detect concealed metal on a person without body contact and may be the answer to constitutional restraints on police search of a suspect for firearms and stolen property. The Frisker may also be used to scan floors, walls, household and office objects for hidden electronic com-

## CHAPLAIN'S CORNER

*Now you count every step I take,  
but then you would cease to spy  
on my sins; you would seal up my  
crime in a bag, and whiten my  
fault over. (Job 14: 16-17)*

Job here wrestles with a problem in his relationship to God which has its resolution later on in the message and spirit of the New Testament. If God is a God who cares deeply about the quality of a man's moral life, how can he ever be a God of mercy and compassion and generosity? If he is a God of forgiveness, is he not in danger of being thought of as a God of indulgence and moral carelessness? W. H. Auden expresses what some morally earnest people fear in the New Testament message when he imagines a criminal saying to himself, "I like committing crimes. God likes forgiving them. Really the world is admirably arranged." Is there any resolution of this dilemma? Christians have found it at the foot of the Cross. No man can accept forgiveness from the crucified and risen Christ and feel relaxed and indifferent about his follies and mistakes and sins. Christ on the Cross manages to offer forgiveness and, at one and the same time, to reenforce and even deepen moral sensitivity. He sees all my sins, but he is ready to blot out and forget them, and yet even as he does so, I feel the enormity of them all the more keenly.

SERVICE TESTS STARTED ON NEW SUMMER UNIFORM IN FOUR COMMANDS WASHINGTON (AFNS) - Distribution of 150 new, two-tone blue summer Air Force uniforms for service tests in four major commands will be completed in early April, officials have announced.

The uniform, which consists of dark blue trousers in a washable construction and two styles of short sleeve, light blue shirts, is being considered as a replacement for the present tan 1505 summer service uniform.

Findings will be reported to the clothing laboratory of the Systems Division at Wright-Patterson AFB, Ohio. If the uniform wins Air Force acceptance, it is expected to take about two years before it can be introduced to the supply system.

## SECURITY CORNER

The following articles extracted from Wing Security Bulletin, No. 3, March 70.

1. New TAC Reg 205-10, Unit & Staff Security Officers, 17 Feb 70, includes changes to be reviewed by Unit Commanders and Security Officers. In addition to the changes noted in the summary, it should be noted that paragraph 1e states performance of unit Security Officer as an additional duty should be reported in the OER of the Security Officer. All Unit Security Officers should obtain a copy of TACR 205-10, for their file.
2. DON'T MISS OUT on completing a Security Termination Statement (AF Form 283) on each person reassigned, separated, or retired from your unit who was granted access to CLASSIFIED INFORMATION on AF Form 47a (Access Authorization Certificate). See paragraph 6-19, AFR 205-1 for procedures on the debriefing. THIS IS QUITE OFTEN OVERLOOKED BY MANY UNITS. Remember it only takes one!
