

BASE CONTRACT BILLETING

The 192d has made interim arrangements for Government Contract Quarters, for the November UTA. Due to the short lead time, for this UTA only, the following procedures will apply:

UTA/AFTP/EQT must be of not less than 2 days duration.

To qualify for contract quarters, you must reside NOT LESS THAN 75 miles from Byrd Field by actual odometer reading.

Contract quarters are available for MEMBERS only. No one will be allowed to pay for wives, children, etc. on a shared basis with the Government for contract quarters.

Upon receipt of this information, phone (no collect calls will be accepted) Area Code 804-222-8884, Ext 47 for Base Billeting Officer (BBO) Lt. Allan R. Smith. Identify yourself, your residence, approximate check in time, and number of nights lodging you require.

BBO will assign you quarters in an available motel and inform you of where to check in. Upon arrival, your room will be reserved in advance by name.

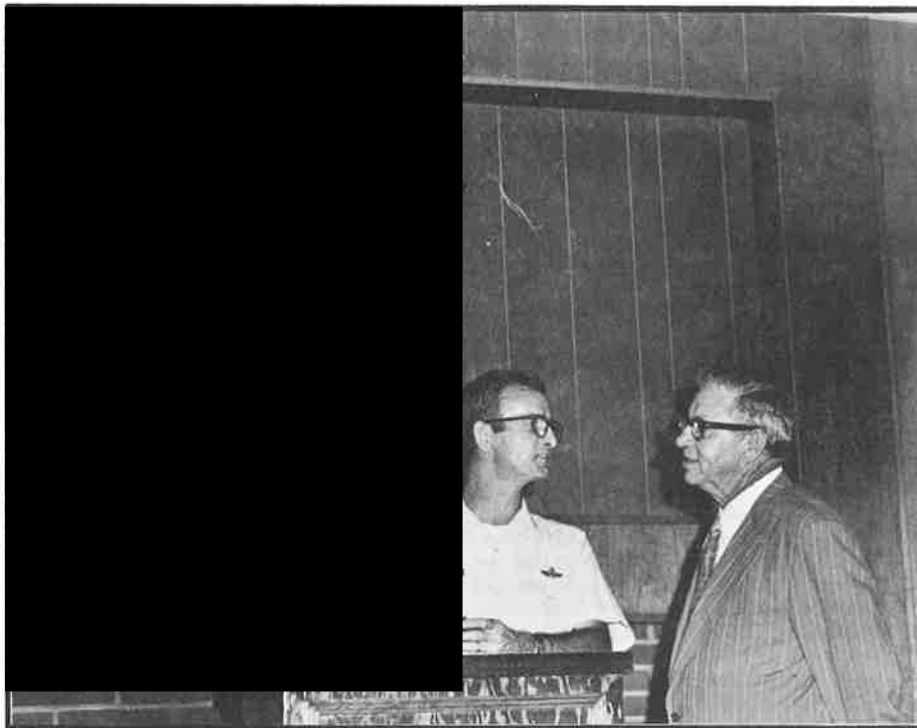
If you will require lodging for Saturday night only, after phoning, report to Lt Smith, BBO, (located in the EMO Office, Base Supply Bldg) not later than 1000 hours, Saturday, 23 Nov UTA to confirm reservations.

Check in and check out times will be stipulated by the motel rules.

The VaANG will assume no liability for damages, bar bills, phone calls, restaurant bills, etc. Abuse of this rule will result in loss of privilege.

Persons who reserve quarters under these provisions, and either do not register or do not attend UTA's will be red-flagged and denied use of contract quarters for the succeeding 2 months. Repeated abuse may result in complete loss of privilege.

Since this is only an interim measure further instructions will be published and forwarded to those members considered eligible not later than the December UTA.

CHARLIE BESENFELDER RETIRES

SMSgt Charles J. Besenfelder, NCOIC and Chief Medical Technician of the 192d TAC Clinic is retiring on 16 November 1974. He will retain his technician status through 15 December 1974.

Sgt Besenfelder was drafted into the U. S. Army in October 1941 and served his Basic Training at Camp Lee, Va. During his Active Army tour he served at various times in the U.S. Army Air Corps, U. S. Army Services Forces, U. S. Air Force and the Allied Military Government, Department of Public Safety. He separated from the U. S. Army as a TSgt in January 1946.

He enlisted in the VaANG in March 1956 as an Apprentice Medical Specialist. He joined the Air Technician Staff in December 1959 as a Supply Specialist, and subsequently transferred to the Dispensary as a Medical Technician. He has served in that capacity both military and

civilian since 1960. He was appointed NCOIC of the Dispensary during the Berlin Call-Up in 1961 and has performed in that status since.

During this period, Sgt Besenfelder has been called upon by The Chief, Air Surgeon, to perform several short tours at that office in the National Guard Bureau. For this and other services, Sgt Besenfelder has received many awards and letters of commendation.

Sgt Besenfelder is married to the former Dorothy Cardwell and has two children and 2 grandchildren. For a time, his son, a 1968 graduate of VMI was a member of the 192d Supply Squadron. His daughter Jane, is a 1972 graduate of Sacred Heart College in Charlotte, N. C. and is now employed in Norfolk, Va as a Counselor/Therapist for retarded children.

SECURITY POLICE COLUMN

TAC Security Guide
(TACRP 205-1)

The purpose of our guide is to provide information to unit/staff security managers appointed in accordance with DOD ISPR 5200.1-R/AFR 205-1/TAC Sup 1, paragraph 13-304. Requiring personnel to read items in the guide, and in other publications furnished by local Chiefs, Security Police, is simply not presenting an effective security education program. Security managers must insure that required security education training is properly accomplished and that there is compliance with other published informational items. Waiting until a semiannual self inspection or annual IG inspection rolls around may be too late. CORRECT DEFICIENCIES WHEN THEY ARE NOTED. (TAC Security Guide, Sep 74)

SECURITY MANAGER RESPONSIBILITIES

Security managers and their designated assistants are responsible, in accordance with DOD ISPR 5200.1-R/AFR 205-1/TAC Sup 1, paragraph 13-304, for the administration of an effective Information Security Program within their activities. Review of TAC IG inspection reports, and results of semiannual administrative security inspection reports, indicate this and other related security managers duties are oftentimes taken lightly. Active participation in the program by security managers is a must. Additionally, commanders and office chiefs have an inherent responsibility for the overall administration and promotion of the program. As a minimum, administration of the program by security managers requires accomplishment of the following duties:

- a. The assignment of proper classifications.
- b. Effective prevention of unauthorized disclosures of classified information.
- c. Progressive downgrading and declassification.
- d. Systematic reviews to eliminate by destruction, transfer, or retirement all unneeded classified material.
- e. Establishment and maintenance of an effective classification management program (where required) encompassing those items contained in DOD ISPR 5200.1-R/AFR 205-1/TAC Sup 1, paragraphs 2-400 and 13-502.
- f. Providing required security education and training for assigned personnel as stated in DOD ISPR 5200.1-R/AFR 205-1/TAC Sup 1, paragraph 10-103 and AFM 207-1, chapter 14, as supplemented. (TAC Security Guide, Sep 74)

NEW DIRECTIVES PENDING

HQ USAF/IGSP has advised that AFRs 205-1, 205-4, 205-32 and DOD 5220.22, Industrial Security Regulation, are being revised. Upon receipt of the new directives TAC supplements will be reaccomplished. Base Chiefs, Security Police and security managers are encouraged to submit recommendations/suggestions relating to our new supplements. Address these comments to TAC/IGS at the earliest convenience. (TAC Security Guide, Sep 74)

INTRODUCING OUR CHAPLAIN

Our new chaplain is Captain Xel Sant'Anna, who recently joined the Virginia Air National Guard as the officer in charge of religious affairs within our unit. Chaplain Sant'Anna was born in Brazil and attended private schools in Sao Paulo, having received his Bachelor of Arts degree from the Assis State College and the Bachelor of Theology degree from the Presbyterian Seminary in Sao Paulo in March 1960. He served the Presbyterian Church in Brazil, and he also taught literature at a teachers college in the State of Sao Paulo. In 1964 he immigrated to the United States and undertook graduate studies at Union Theological Seminary in Richmond, having received the degrees of Master in Theology and Doctor of Theology from UTS. He has also undertaken special training in the area of counseling and career assessment.

Chaplain Sant'Anna has served churches in West Virginia, and since 1974 he has been pastor of the Sandston Presbyterian Church in Sandston, Virginia. His professional activities have led him to serve Hanover Presbytery, a regional Council of the Presbyterian Church, as member of its Executive Council and Chairman of the Commission on the Minister (ministerial relations); and the Synod of the Virginias as member of its Mission Group on Professional Development. His involvement in community services has placed him on the Board of Directors of the Sandston Rotary Club, Board of Directors of the Henrico Chapter of the American Red Cross, and member of the Executive Committee of the Virginia Committee of the Partners of the Americas.

On November 7, 8, 9 and 10 the 149TFS held its annual fall weapons delivery week-end. The purpose of the week-end was to provide a concentrated training exercise in weapons delivery for all F-105 pilots attached to the 192d TFG.

Air Force ORI qualifying criteria was shattered time and again as the bombs and bullets of the pilots found their mark. Three events were scored during the competition: Low angle dive bomb, high angle dive bomb, and strafe. In low angle dive bomb, the pilots faced a qualifying criteria of 100 feet (i.e. to qualify a bomb cannot miss the target by more than 100 feet). The pilots responded with a total average of 72 feet for all bombs dropped. In high angle dive bomb, the pilots faced a 140 foot qualifying criteria and responded with a fantastic average of 99 feet for all bombs dropped. In strafe, qualifying criteria states that 25% of all bullets fired must hit the target. The pilots mastered this task with a 34% average.

Highlights of the week-end included Bill Haymes saturating the strafe target on Saturday with 80 hits for an 80% average, Jeff Wilkins scoring 2 bulls-eyes on Friday in low angle bombing, and "B" Flight of the 149TFS dominating strafe with a 63% average. In addition, 71 weapons sorties, 2 FCF flights, 3 Instrument checks, and 4 air refueling flights were flown in the four day exercise with only four scheduled sorties not accomplished.

Lt Col Lemmond, Commander of the 149TFS, termed the results of the exercise as outstanding. The 149 TFS wishes to express its thanks for a job well done to the support elements of the 192TFG who contributed to the overall success of the four day exercise.
