

## TSG KOZUO WEBB OUTSTANDING VIRGINIA GUARDSMAN FOR 1977

"Normally you wouldn't think a man in the Metal Shop would have this kind of opportunity."

As soon as he said that, TSG Kozuo Webb, Metals Processing Technician in the Field Maintenance section of the 192d Tactical Fighter Group, acknowledged that he did have the opportunity. Not only did he have the opportunity, but he cashed in on it by being chosen as the Outstanding Virginia Enlisted Guardsman for 1977.

But being on top isn't new to SGT Webb. He's an avid karate enthusiast and he's so good, in fact, that he's a former Virginia state champion.

An eight year veteran of the 192d TFG, SGT Webb was selected to represent the Virginia Air National Guard in the annual competition which was held in May. Five other contestants, all Army Guardsmen, were in the running. There are approximately 5,000 - 6,000 enlisted Guardsmen in Virginia.

A selection board comprised of 10 Senior NCOs and officers from the Air and Army Guard made the choice after interviewing each candidate. As a preliminary, each individual had an advocate to speak to the board on his behalf.

As the winner, SGT Webb received a \$50 savings bond upon the announcement of his selection, and in July he was honored at a ceremony held for several state military honorees. At the ceremony, SGT Webb received an engraved Minuteman trophy and the Virginia Commendation Medal.

Of the whole experience SGT Webb said, "I felt honored to represent the Unit. A lot of others could have done it." Webb said he was impressed with the selection board because it was so thorough in covering aspects of his Guard and private life in evaluating him.

"When I came out of the board, I thought that whoever won would sure deserve it", Webb concluded.

According to Webb, there were several surprises as a result of his winning. "My wife couldn't believe it," Webb laughed. Also, Webb was given quite a thrill when he was taken for a turn in the back seat of an F-105F - his reward from the 149th TFS.

Ultimately, SGT Webb wants to work toward obtaining a commission in the Guard, if possible.

SGT Webb and his wife, Kathleen, have two sons, Nathan and Neal, and they reside in Highland Springs.

This year marks the second time in the last three years that a member of the 192d has won the state honor.

### 16 TAKE ADVANTAGE OF TUITION \$\$ BY EXTENDING

Sixteen members of the 192d completed the paperwork during the July UTA for reenlisting to qualify for tuition assistance for the 1978-79 school year, according to Sgt Jean Friedman, Career Advisory Technician.

There are several others who have completed the paperwork since the UTA. When those not needing to extend are counted, about 70 members of the 192d have applied for the program.

Why the interest in reenlisting? One of the provisions of the tuition assistance measure is that the recipient must be a member of the Virginia National Guard when applying and while in school. Furthermore, the Guardsman must have two years' retainability upon completion of the academic period.

The 1977 session of the State Legislature finally passed a Tuition Assistance bill providing for aid to National Guardsmen in Virginia who attend institutions of higher learning in Virginia. Since funding for the bill was deferred until 1978, this fall session at community colleges, universities and technical schools will be the first time Guardsmen will have an opportunity to receive the assistance.

The Virginia National Guard Association has pushed for tuition assistance legislation for several years and counts this measure as one of its greatest victories.

There is still time to apply for tuition assistance for the spring term, and any Guardsman interested in details should see LtCol Raymond Germain, Maj Basil Evans, or Capt Conrad Slate during the August UTA for further information and applications. The cutoff date for the spring term applications is 1 November.

## CHAPLAIN'S CORNER

"WHAT DOES THE LORD REQUIRE...?"

These familiar words from the prophet Micah are the Chapel Program Emphasis Theme for the period of September 1978-August 1979. The theme is a question that challenges us, individually and as community, to self search and investigation to find out and live the proper answers.

Under the inspiration of this theme the Chaplain Section will attempt to find new dimensions related to our relationship with God and our fellow man.

What are God's demands? We hope that we will get some help as we offer to you some considerations pertaining to the prophet Micah, his time, and his message, in a series of short articles to be published monthly in the "Vanguard". Today we will consider the prophet Micah.

Very little is known of Micah himself. His name is an abbreviation of Micaiah which means "Who is like the Lord?" His home was the small village of Mareshah (see Chapter 1:1; 14; 15 and Jeremiah 26:18), located on the border line between Judah and Philistine. Micah was a young contemporary of the prophets Hosea and Isaiah. He was the small town man who came to the big city, to Jerusalem, to deliver God's message of judgement and hope.

As we follow his prophetic career we learn that Micah was marked by outstanding intelligence, fearlessness and compassion. His knowledge and denunciation of the evils of Jerusalem and his sympathy toward the underdogs and victims of the system, show us that this prophet was a person endowed with great mind, great courage, and great heart. And we know that we will learn from his intelligence, courage and compassion, as we consider our Emphasis Theme for the year ahead.

## SAFETY

Somebody has said that if noise made your ears bleed, you would do more about this serious health hazard.

Why is hearing so important? The reasons are many. Consider:

- Through hearing you are able to communicate, to learn, to be entertained, and even to enjoy the "sound" of peace and quiet.

- In a sense, your ability to hear enables you to "see" 360 degrees about you. If someone is approaching you from behind, although you cannot see them you can hear them.

- Even while you are asleep, your sense of hearing is awake to receive signals that may warn you of impending danger.

How can you tell when the noise is loud enough to damage your hearing? Many of the hazardous noise areas, equipment, machinery, and tools have already been posted or labeled as dangerous to your hearing. Become familiar with and heed these warnings. Some noise-producing operations are of a transient nature and may not be posted, but if you have to raise your voice to be understood at a distance of one foot, it is likely that you are in a hazardous noise environment.

Noise levels that are damaging may not be considered very loud by some people. They may say that the noise doesn't bother them, that they get used to it. What you must remember is that whether or not this noise bothers you or you get used to it, this noise is what can and does damage your hearing.

While frequent exposure to noise does not immediately cause irreparable damage to your hearing mechanism, after repeated exposure it will. It is important that you know that this damage is not reparable, that it is permanent!

Only by using readily available personal hearing protectors whenever you are exposed to noise-at work or at home-are you doing your part in protecting yourself from this serious health problem. Taken from "Navy Lifeline".

## PISTOL TEAM WINS AGAIN!

## REDUCTION IN SGLI PREMIUMS

Servicemen's Group Life Insurance (SGLI) premiums have been reduced, effective July 1.

Monthly premiums for \$20,000 maximum SGLI coverage have been lowered 40 cents to \$3. New premium rates for other amounts of coverage, with the old rate shown in parentheses, are: \$15,000, \$2.25 (\$2.55); \$10,000, \$1.50 (\$1.70); and \$5,000, 75 cents (85 cents).

SGLI premiums are deducted from Air Guard members' paychecks. Air Force Manpower and Personnel Center officials said that the net pay difference resulting from the premium reduction will appear in the July paychecks.

## ANG TO GET MORE MODERN PLANES

A number of ANG organizations are scheduled to convert to more modern aircraft during fiscal year 1979.

The proposed conversions include:  
Ft Smith, Ark - The 188th Tactical Fighter Group will convert from F-100D/F aircraft to F-4Cs.

Bradley IAP, Conn - The 103d TFG will receive A-10 aircraft to replace F-100D/F fighters.

Dobbins AFB, Ga - The 116th TFW will replace its F-100D/Fs with F-105Gs.

Capital Airport, Ill - The 183rd TFG will receive six additional F-4C fighters.

Ft Wayne MAP, Ind - The 122d TFW will convert from F-100D/F aircraft to F-4Cs.

Hulman Field, Ind - The 181st TFW will convert from F-100D/F to F-4s.

New Orleans, La - The 159th TFG will receive F-4Cs to replace the F-100D/F.

Barnes Airport, Mass - The 104th TFG will replace its F-100D/F fighters with A-10 aircraft.

Selfridge ANGB, Mich - The 127th TFW will replace F-100D/F fighters with A-7 aircraft.

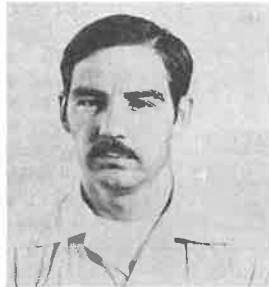

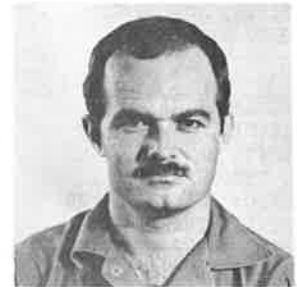

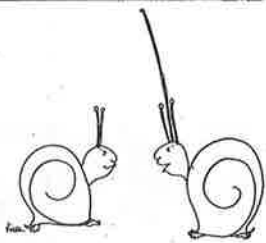
# SECURITY

New Facilities For SPs. The Security Police Section has moved to new facilities located in the southwest corner of Hangar, the old Operations Section. New Class "A" extensions are 320 and 321.

Restricted Area Requirements During ORI. Commanders and supervisors are reminded that in the future during ORIs the unit will be required to simulate Priority "B" for Restricted Areas, (Flightline Aircraft Area and Command Post). Restricted Area Badges are required for entry to restricted areas during ORIs. Commanders and Unit Security Managers please insure that all personnel that require entry to restricted areas have security clearances. Restricted Area Badges cannot be issued to individuals that do not have a clearance.

## READINESS IS OUR PROFESSION

HQ TAC - "Readiness Is Our Profession," a phrase coined by Gen. Robert J. Dixon at his retirement ceremony, is now the official motto of the Tactical Air Command.

The Air Force Military Personnel Center at Randolph AFB, TX, approved the motto, proposed by the TAC Commander shortly before his retirement on April 30, 1978. General Dixon said in his farewell address to the men and women of TAC, "All TAC people and their families must work to maintain readiness...TAC's readiness is a product of people caring, caring to know and to manage their destiny."

The motto now is officially in the Air Force heraldic records.

## SECURITY MANAGERS, DID YOU KNOW?

- Personnel departing on a PCS move do not need a security debriefing unless they have had access under a special access program and the directive for that special program so requires.

- If an incoming individual's clearance and investigative data are listed on his/her special orders, it is not necessary to process a local files check, AF Form 2583, unless the individual requires special access or clearance action.

- Microfiche envelopes/holders must be marked to reflect the highest degree of classified contained therein.

- Personnel who have access to COSMIC Top Secret material must be re-briefed annually IAW AFR 205-43.

- An audit/inventory of Top Secret accounts is required each 12 months or upon change of Top Secret Control Officer (TSCO).

- Attendance at the quarterly Security Manager's meeting is mandatory.

- TAC/SP has requested that the IG make wear of Restricted Area Badges a special interest item. Why not check your personnel for compliance now?

- You are required to administer the security education/motivation program required by AFR 207-1 as well as the program required by AFR 205-1.

- The time for the next semiannual security self-inspection is fast approaching? Why not make this your best yet? Give your entire security program a close examination.

- A new Executive Order on Information Security was recently signed by the President? Details will be available soon.

- Funds, weapons, medical security items, controlled drugs, or precious metals, may not be stored in security containers. The keys and/or combinations needed to gain access to such items are also forbidden from storage in security containers.

- You are responsible for informing your commander or staff agency chief of the security status within your unit/agency, for encouraging personnel to report anything they feel might lead to a security incident, and for preventing violations by diagnosing and eliminating security problems.

- Security incidents are almost always caused by "carelessness" on the part of a person or persons. Among the more common acts of "carelessness" are:

-- Leaving classified information on desks or exposed elsewhere in unoccupied offices or rooms.

-- Discussing classified information with unauthorized person(s).

-- Attempting to talk "around" classified on the telephone.

-- Storing classified in unauthorized containers such as key locked cabinets, drawers desks, etc.

-- Throwing classified waste in trash cans.

-- Assuming a security container is locked.

-- Failing to properly do room and area checks at the end of the duty day.

-- Improper wrapping/packaging of classified for mailing/shipping.

-- Not using the prescribed class of main, for example, using first class when certified or registered is required.

- If you are returning a security container to supply channels, the combination must be set to 50-25-50. (From TACRP 205-1)
