# COL Heath Becomes Assistant AG For Air; Chief Of Staff To COL Mattox

Major General William J. McCaddin, Adjutant General of Virginia announced that effective 15 Dec 81, Colonel Claude F. Heath, Chief of Staff will assume the duties of Assistant Adjutant General for Air for the Virginia Air National Guard replacing Brigadier General William Haymes who retired 31 Oct 81.

Colonel Alvah S. Mattox, Jr., Commander of the 192TFG will assume the duties of Chief of Staff for the VaANG while LtCol Hartwell F. Coke, IV will become the Group Commander. Coke currently serves as the Director of Operations for the 192TFG and as the Air Commander for the civilian technician detachment.

Heath has held a number of positions with the Air National Guard including those of Group Commander and Air Commander. He is a veteran of more than 31 years of military



service. The Norfolk native flew 223 combat hours and 60 aerial missions during the Korean conflict. He has also served as the Director of Operations, Air Operations Officer and as a flight commander. In his civilian position he serves as the Executive Support Staff Officer to the Adjutant General.

Mattox, a Captain on 727 airliners for American Airlines, has served as the Group Commander since Janu-




ary 1980. A graduate of Virginia Military Institute and a resident of Woodbridge, Virginia, Colonel Mattox is a veteran of more than 26 years of military service. He is a command pilot with more than 8,500 hours of flying time. He has flown seventeen different types of aircraft.

Coke, of Quinton, Virginia is an experienced pilot with more than 5,000 flying hours to his credit. Coke assumes the dual role of Commander of the 192TFG and that of Air Commander of the technician detachment giving him full responsibility for the operations of the Air National Guard's flying operations. The Norfolk, Virginia native attended Norview High School, the Norfolk Extension of VPI and William and Mary College. Prior to assuming the position of Director of Operations, Coke served as Chief of Safety, and as a flight commander.

According to the Adjutant General William J. McCaddin, "These men are some of the most dedicated airmen in the world. They take their role as part of the total force seriously and I know that the VaANG is ready to accept the call to active duty if and when the need arises. These men follow a long tradition of Virginians dedicated to preserving freedom throughout the world. I am proud to have them as part of our National Guard force."

# Employer Must Honor Guard Obligations

The U.S. Code places the responsibility on the guard member to attend military training and on the employer to excuse the guard member for military training. The guard member must inform the employer of training dates and request leave in advance. An employer may not discharge a guard member because of participation in National Guard training.

According to Virginia law, an employer who obstructs or annoys a guard member at his civilian employment because of National Guard participation is guilty of a misdemenor.

Making current copies of orders for UTAs and annual field training available to employers as soon as possible may help alleviate some problems.

Each employment case is different and should be discussed with legal counsel. The Base Legal Office is open each UTA and appointments are made by telephoning ext "A" 434, or "C" 88.

## **Hazard Reporting**

How many times have you noticed a safety hazard which continues to exist? Have you brought the hazard to the attention of your supervisor and nothing happened? If your answers to these questions are "yes", now is the time to take action and get the hazard corrected. Submit a hazard report (AF Form 457). These forms are available in the work area. Make sure the hazard report contains specific information on the hazard. After you complete the form, submit it to the Safety office, (SE). We will staff your hazard report and either correct a valid hazard or take action to temporarily abate the hazard. We will provide you feedback on your hazard report in approximately 30. days. It takes approximately 10 minutes to find and fill out a hazard report. In that same time, 2 Americans will be killed and approximately 200 will suffer disabling injuries. Mishap prevention is the name of the game.

#### **New Year Goals**

#### **Guard Plates-The Public**

Virginia Guard members were provided a benefit last year by the General Assembly that we should all be proud of. The passage of legislation authorizing Guard license plates at one-half normal cost was recognization by the State of the professional personnel the National Guard has and is trying to retain.

However, along with that benefit goes the same responsibility that National Guard members have when they wear the uniform. If you have elected to take advantage of the reduced cost of guard plates you must remain aware that your vehicle is a visual reminder to the general public of your guard affiliation, and abuse could result in loss of this privilege.

The Adjutant General's office has received telephone calls from irate civilians when someone with guard plates on their cars has either driven recklessly or gotten in an argument with a civilian. Remember the visibility that goes with the license plates and don't jeopardize your benefit.

#### Misuse Of Funds Receives Attention: Dial 368 For RMS Hot Line

Fraud, waste, and abuse in the federal government has received considerable attention from the President, Congress, and the news media in recent months, and rightly so. We've all probably either seen or heard of cases where we felt the government was 'ripped-off' but ignored it by saying something like "that's too bad, but what can I do about it."

The truth is we can all make a significant contribution. Particularly in the areas of waste and abuse. Our current aircraft is not that much different from the previous one, or any other in the inventory for that matter, when it comes to expensive components.

There are some very expensive parts required to keep the aircraft flying, and waste or abuse of these parts only drive up the cost of High costs are not operation. necessarily restricted to large Small electronic parts either. component boards, some screws, gaskets, hoses, as well as associated support equipment can all carry a high replacement value. The list of items that could be wasted and abused is endless, running the gimbit from typewriters to utilization of time. So you see, as an individual there probably is something you can do.

Secretary Weinberger noted recently, "The commitment to reduce fraud and waste cannot be met by simply establishing a new overnight office and publicizing a hotline."

"Our efforts to attack fraud, waste and inefficiency will require cooperation and support of all DOD personnel. You are the key to the success of this effort, and success is essential if we are going to acquire the resources and carry out the programs required to strengthen and improve our military forces."

192TFG people who wish to report suspected cases of waste, fraud, or abuse may use the RMS hot line, extension 368 Class "A" or report it to your immediate supervisor.



## Agent Orange Studies Disseminated by VA

A compilation of world scientific literature on Agent Orange and other herbicides used in Vietnam has been distributed by the Veterans Administration to researchers throughout government, the private sector scientific community, and the veterans affairs committees of the Congress.

The two-volume report, compiled under a VA contract, covers some 1,200 documents spanning more than 20

years. This independent review of literature, mandated by Public Law 96-151, is part of VA's continuing effort to stimulate scientific inquiry on a subject that has caused widespread concern among

Vietnam veterans.
Since 1978, VA has examined some 65,000 veterans concerned about possible effects of being in Vietnam during jungle spraying operations carried out between 1962 and 1971. More than

10,500 have filed claims for VA disability compensation on the basis of a great variety of medical symptoms or fear that such symptoms might develop.

A wide range of research on the subject, stimulated by a special 15-member advisory committee set up by VA, has been undertaken. Recently President Ronald Reagan elevated coordination of such research to cabinet council status.

A Pitch to Voluntary CDC and Voluntary Specialized Course Enrollees
